RESOLUTION NUMBER 07-15

A RESOLUTION OF THE TOWN OF FORT MYERS BEACH, FLORIDA, CERTIFYING THE RESULTS OF THE ELECTION; CANDIDATES FOR SEAT ONE; CANDIDATES FOR SEAT TWO; DECLARATION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Charter requires periodic elections for membership on the council. Pursuant thereto, the Town Council of the Town of Fort Myers Beach, Florida called an election in the Town of Fort Myers Beach, which was duly held on the 13TH day of March, 2007, for the purpose of having all of the qualified electors within the Town determine the members of the Town Council for seats #1 and #2.

IT IS HEREBY RESOLVED BY THE TOWN OF FORT MYERS BEACH, FLORIDA:

Section 1. Certification of Results of Election. It is hereby certified that the appropriate election officials have canvassed the ballots and certified same to the Lee County Supervisor of Elections and the Supervisor has in turn, certified the election results to the Town Council of the Town of Fort Myers Beach, Florida.

Section 2. Candidates For Seat One. The votes received by the candidates for Council member Seat #1 are as follows:

HERB ACKEN	1174	59.15%
PATRICIA "PAT" SMITH	811	40.85%

Section 3. Candidates For Seat Two. The votes received by the candidates for Council member Seat #2, are as follows:

LARRY KIKER	1295	64.75%
GARR REYNOLDS	705	35.25 %

Section 4. Declaration. The Town Council hereby declares Herb Acken elected as Council member for **Seat #1** and Larry Kiker elected as Council member for **Seat #2**.

Section 5. Effective Date. This Resolution shall take effect immediately upon its adoption by the Town Council of the Town of Fort Myers Beach, Florida.




