

RESOLUTION NUMBER 10-07
A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS
BEACH, FLORIDA, AUTHORIZING VARIOUS TOWN OFFICIALS TO HAVE
SIGNATORY AUTHORITY ON TOWN BANK ACCOUNTS, AND PROVIDING AN
EFFECTIVE DATE

WHEREAS, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

WHEREAS, Article X of the Town Charter of the Town of Fort Myers Beach empowers the Town to adopt, amend, or repeal such ordinances and resolutions as may be required for the proper governing of the Town; and

WHEREAS, the Town currently has four business banking accounts with SunTrust Bank and SunTrust Bank requires that any change in the signature card be approved by the Town Council via resolution; and

WHEREAS, Terrance E. Stewart was selected as the Interim Town Manager for the Town of Fort Myers Beach as of the 1st day of February, 2010, necessitating a change in the signature card referenced above.

IT IS HEREBY RESOLVED BY THE TOWN OF FORT MYERS BEACH AS FOLLOWS:

Section 1. Incorporation of Whereas Clauses. The above "Whereas" clauses are hereby incorporated by reference as though fully set forth herein.

Section 2. Authorization to Sign Business Account Signature Card for SunTrust Bank. The following persons are hereby authorized to sign the signature cards for the Town Business Accounts held by SunTrust Bank under Accounts # 1000004168950, 1000004168943, and 0153531004956, 1000034162510 to perform the normal ministerial function which accompany such authority:




Section 4. Effective Date. This resolution shall take effect immediately upon its adoption by the Town Council of the Town of Fort Myers Beach.
