

RESOLUTION NO. 18-41

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA AUTHORIZING THE TOWN MANAGER OR THE TOWN MANAGER'S DESIGNEE TO PROVIDE WASTE COLLECTION SERVICES FOR THE TIMES SQUARE MERCHANTS UNTIL FEBRUARY 1ST, 2019 PROVIDING ADVANCED DISPOSAL TIME TO INITIATE COLLECTION SERVICES FOR THE MERCHANTS; AUTHORIZING THE TOWN MANAGER TO CHARGE MERCHANTS THE FEE(S) FOR COLLECTION AND DISPOSAL SERVICES; PROVIDING AN EFFECTIVE DATE.

WHEREAS: the Town of Fort Myers Beach has performed waste collection services for the Times Square Merchants since the Town's incorporation in 1995; and

WHEREAS: the Town intends to relinquish its collection services on or before February 1st 2019; and

WHEREAS: the Town prefers to have Advanced Disposal or another service provider for Fort Myers Beach to provide collection services for the Times Square Merchants; and

WHEREAS: in order for Advanced Disposal to coordinate, schedule and enter into user contracts, in the fiscal year 2019 interim period, the Town will continue to provide collection services based on a per tote disposal cost, monthly recycling for uncontaminated cardboard, plus monthly Fort Myers Beach staff collection cost divided by the number of totes; and

WHEREAS: the Town Council desires to authorize the Town Manager or the Town Manager's designee, to provide collection and billing as prescribed herein; and

NOW, THEREFORE, IT IS HEREBY RESOLVED, BY THE TOWN OF FORT MYERS BEACH, Florida as follows:

Section I: The above recitals are true and correct and incorporated herein.

Section II. The 2017-2018 fee will be applicable from October 1, 2018 to January 31, 2019.

Section III. This Resolution shall take effect immediately upon its adoption.

THE FOREGOING RESOLUTION was adopted by the Town Council upon a motion by Vice Mayor Shamp and seconded by Council Member Boback and upon being put to a vote, the result was as follows:
