

RESOLUTION NUMBER 19-05

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA AUTHORIZING THE TRANSITION FROM THE CODE RED NOTIFICATION SYSTEM TO ALERTLEE NOTIFICATION SYSTEM, AUTHORIZING THE TOWN MANAGER TO EXECUTE DOCUMENTS IN CONNECTION WITH THIS TRANSITION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS: The Town of Fort Myers Beach currently utilizes the CodeRed notification system; and

WHEREAS: The State of Florida is offering to provide use of a new free notification system Everbridge; and

WHEREAS: Lee County Emergency Management will provide this new access to the Town of Fort Myers Beach throughout and after the transition from CodeRed to the mass notification system AlertLee provided by Everbridge over the next year ; and

WHEREAS: The AlertLee system will be provided at no additional expense and will more effectively inform residents during times of emergencies through collaboration with Lee County Emergency Management; and

WHEREAS: Lee County Emergency Management will administer and maintain the AlertLee system with the purpose of alerting citizens and county Government departments, agencies, and officials; and

WHEREAS: The Town Council authorizes the Town Manager to execute the required documents as necessary to proceed with this transition.

NOW, THEREFORE, BE IT HEREBY RESOLVED, BY THE TOWN COUNCIL OF THE TOWN OF FOT MYERS BEACH, Florida as follows:

Section I. The above recitals are true, correct and incorporated herein by this reference.

Section II. The Town Council of the Town of Fort Myers Beach, Florida encourages the implementation of AlertLee Notification System operated and maintained by Lee County Emergency Management and authorizes the Town Manager to take the necessary action to implement the services and execute contract documents as required. The Town will not discontinue CodeRed until AlertLee is operating and meeting all Town operational needs.

Section III. The Town Manager or designee is authorized to execute any agreements in connection with the transition to AlertLee Notification System on behalf of the Town.

Section IV. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was adopted by the Town Council upon a motion by Council Member Shamp and seconded by Council Member Hosafros, and upon being put to a vote, the result was as follows:




