RESOLUTION NUMBER 04-10

A RESOLUTION OF THE TOWN OF FORT MYERS BEACH, FLORIDA, CERTIFYING THE RESULTS OF THE ELECTION; CANDIDATES FOR SEAT ONE; CANDIDATES FOR SEAT TWO; DECLARATION AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Charter requires periodic elections for membership on the council and the council called an election in the Town of Fort Myers Beach, to be held the 9th day of March, 2004, for the purpose of having all of the qualified electors within the Town to determine the members of the council for seats #1 and #2.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA:

Section 1. Certificate of results of Election. There is hereby certified that the appropriate election officials have canvassed the ballots and certified same to the Lee County Supervisor of Elections and the Supervisor has in turn, certified the election results to the Town of Fort Myers Beach Council.

Section 2. Candidates For Seat One. The votes received by the candidates for Council member Seat #1, are as follows:

DON MASSUCCO 1,134 56.22%

ROXIE SMITH 883 43.78%

Section 3. Candidates For Seat Two. The votes received by the candidates for Council member Seat #2, are as follows:

JODI HESTER 714 34.81%

GARR REYNOLDS 684 33.35%

JOHN SCANLON 406 19.80%

BILL MC CARTHY 247 12.04%

Section 4. Declaration. The Town Council hereby declares **Don Massucco** elected as Council member **Seat #1**, and that there shall be a run off election on Tuesday, April 13th, 2004, between **Jodi Hester** and **Garr Reynolds** to determine Council member **Seat #2**.


Section 5. Effective Date. This resolution shall take effect immediately upon its adoption by the Fort Myers Beach Town Council.

The foregoing resolution was adopted by the Fort Myers Beach Town Council upon being put to a vote, the result was as follows:


