

RESOLUTION NO. 22-33

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, ADOPTING THE FINAL BUDGET FOR FISCAL YEAR 2022-2023 COMMENCING OCTOBER 1, 2022, AND ENDING ON SEPTEMBER 30, 2023; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

WHEREAS, Article X of the Town Charter of the Town of Fort Myers Beach ("Town") empowers the Town to adopt, amend, or repeal such ordinances and resolutions as may be required for the proper governing of the Town; and

WHEREAS, Section 200.065, *Florida Statutes* establishes the method of determining and levying an ad valorem millage rate and adopting a budget for all taxing authorities in the State of Florida; and

WHEREAS, following proper notice, on September 22, 2022, the Town Council held the required public hearing to consider any adjustments to the tentative budget adopted on September 8, 2022, and, following public input, adopted a final ad valorem millage rate and final budget for fiscal year 2022-2023.

NOW THEREFORE, IT IS HEREBY RESOLVED BY THE TOWN OF FORT MYERS BEACH AS FOLLOWS:

Section 1. The above recitals are true, correct, and incorporated herein by this reference.

Section 2. The Town Council does hereby adopt the final annual budget for fiscal year 2022-2023, attached hereto and incorporated herein as Exhibit "A".

Section 3. The Town Council does hereby adopt the capital improvement plan for fiscal year 2022-2023, attached hereto and incorporated herein as Exhibit "B".

Section 4. A public meeting and hearing were held on September 22, 2022, at 5:01 PM at the Town Hall of the Town of Fort Myers Beach, Florida located at 2525 Estero Boulevard, Fort Myers Beach, Florida to consider and adopt the final Town budget and capital improvement plan for fiscal year 2022-2023.


Section 6. This resolution shall take effect immediately upon its adoption by the Town Council of the Town of Fort Myers Beach.







Tax Percentage to Taxing Authority








Town of Fort Myers Beach 5 Years Average Taxable Value of Residential Property




ORGANIZATIONAL CHART
