

RESOLUTION NUMBER 23-167

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA, AMENDING THE FISCAL YEAR 2023-2024 FEE SCHEDULE ADOPTED ON SEPTEMBER 25, 2023 TO ADJUST THE FEE FOR THE MEMORIAL BENCH PROGRAM; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

WHEREAS, Article X of the Town Charter empowers the Town Council to adopt, amend, or repeal such ordinances and resolutions as may be required for the proper governing of the Town; and

WHEREAS, the Town of Fort Myers Beach has been receiving new applications for their Memorial Bench Program; and

WHEREAS, the Town is adjusting the fee for the Memorial Benches and reducing the base price \$10 USD to match previous fee in past years from \$575 to \$565.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE TOWN OF FORT MYERS BEACH AS FOLLOWS:

Section 1. The above recitals are true and correct and are hereby incorporated by reference as though fully set forth herein and are hereby adopted as the legislative and administrative findings of the Town Council.

Section 2. This resolution adjusts the Memorial Bench fee on the Fee Schedule adopted on September 25, 2023

Section 3. This Resolution shall take effect immediately upon its adoption.
