

RESOLUTION NUMBER 23-169

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA, GRANTING AUTHORITY TO THE TOWN MANAGER TO SIGN FEDERAL CONTRACTS ON BEHALF OF THE TOWN IN ACCORANCE WITH THE APPLICABLE LAWS AND REGULATIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

WHEREAS, Article X of the Town Charter of the Town of Fort Myers Beach ("Town") empowers the Town to adopt, amend, or repeal such ordinances and resolutions as may be required for the proper governing of the Town; and the Town of Fort Myers Beach regularly engages in projects and initiatives that involve federal funding and participations, and

WHEREAS, the Town Manager has demonstrated competence and responsibility in managing the affairs of the Town, including by not limited to financial matters; and

WHEREAS, it is in the best interest of the Town to streamline the process of federal contract signing to ensure prompt project execution and compliance with federal requirements.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN OF FORT MYERS BEACH, AS FOLLOWS:

Section 1. The above recitals are true and correct and are hereby incorporated by reference as though fully set forth herein and are hereby adopted as the legislative and administrative findings of the Town Council.

Section 2. The Manager is hereby granted the authority to sign federal contracts on behalf of the Town of Fort Myers Beach.

Section 3. The authority granted to the Town Manager is subject to compliance with all applicable federal laws, regulations and guidelines governing the execution of federal contracts.

Section 4. The Town Manager shall keep the Town of Fort Myers Beach Council informed of all federal contracts entered into on behalf of the Town.

Section 5. This resolution shall take effect immediately.

The foregoing Resolution was adopted by the Town Council upon a motion by Mayor Allers and seconded by Council Member Woodson, and upon being put to a vote, the result was as follows:
