

RESOLUTION NO. 23- 158

A RESOLUTION OF THE TOWN OF FORT MYERS BEACH, LEE COUNTY, FLORIDA, PROVIDING FOR THE TENTATIVE AWARD OF A CONTRACT TO ANDREW SITEWORK, LLC., FOR THE CONSTRUCTION OF THE TIER 1 SIDE STREETS WATER AND STORMWATER IMPROVEMENTS PROJECT – GROUPS A, B, C, AND D. (BID NO. ITB-23-18-UT), PURSUANT TO THE FLORIDA STATE REVOLVING FUND LOAN PROGRAM, SUBJECT TO FDEP APPROVAL; AUTHORIZING EXECUTION OF THE CONTRACT DOCUMENTS BY THE TOWN MANAGER; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, The Town of Fort Myers Beach wishes to utilize funds from the Florida State Revolving Fund (SRF) Loan Program to perform the Tier 1 Side Streets Water and Stormwater Improvements Project – Groups A, B, C, and D. (Bid No. ITB-23-18-UT); and

WHEREAS, On August 2nd, 2023 proposals were received for the Tier 1 Side Streets Water and Stormwater Improvements Project – Group A, B, C, and D. (Bid No. ITB-23-18-UT); and

WHEREAS, Tetra Tech, Inc., the Town’s engineer for the project, has recommended award of the contract to Andrew Sitework, LLC., in the amount of \$23,009,179.00.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA AS FOLLOWS:

SECTION 1. The Town of Fort Myers Beach, a Florida municipal corporation, hereby tentatively awards the contract for the construction of the Tier 1 Side Streets Water and Stormwater Improvements Project – Group A, B, C, and D. (Bid No. ITB-23-18-UT) Andrew Sitework, LLC. for a total contract amount of \$23,009,179.00, subject to bid award approval by the Florida Department of Environmental Protection (FDEP).

SECTION 2. The Town Manager is hereby authorized to execute the contract documents.

SECTION 3. Effective Date. This resolution shall take effect immediately upon adoption.
