

**RESOLUTION NUMBER 24-36**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA AUTHORIZING THE MAYOR, TOWN MANAGER, OR A DESIGNEE THEREOF TO APPLY FOR AND ADMINISTER A GRANT FROM THE LEE COUNTY CDBG-DR RECOVERY AND RESILIENCY PLANNING PROGRAM FOR LONG TERM RECOVERY AND COMPREHENSIVE PLANNING EFFORTS; AUTHORIZING THE MAYOR, TOWN MANAGER, OR DESIGNEE TO EXECUTE RELATED DOCUMENTS; AND FOR RELATED PURPOSES; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

**WHEREAS**, Article X of the Town Charter of the Town of Fort Myers Beach empowers the Town to adopt, amend, or repeal such ordinances and resolution as may be required for the proper governing of the Town; and

**WHEREAS**, the Town of Fort Myers Beach, Florida (the “Town”) has an opportunity to apply for grant funding from the Lee County CDBG-DR Recovery and Resiliency Planning Program (the “Program”); and

**WHEREAS**, the Town desires to apply for grant funding from the Program (the “Grant”) to provide the Town with funds for Long Term Recovery and Comprehensive Planning efforts; and

**WHEREAS**, as part of the application for the Grant, the Town must submit a resolution authorizing submission of an application for the Grant and administration of the Grant on behalf of the Town; and

**WHEREAS**, the Town Council finds and determines that it is in the best interest of the Town and its citizens to authorize the application for the Grant and the administration thereof if the Grant is awarded; and

**WHEREAS**, the Town desires to authorize the Mayor, the Town Manager or the aforementioned officer’s designees, to apply for the Grant from the Program and administer the Grant for an on behalf of the Town; and

**WHEREAS**, the Town Council desires to authorize the Mayor, the Town Manager, or the aforementioned officer’s designees to execute and deliver all documents necessary to apply for the Grant and carry out the administration of same.

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE TOWN OF FORT MYERS BEACH AS FOLLOWS:**

Section 1. The above recitals are true and correct and are hereby incorporated by reference as though fully set forth herein.

Section 2. The Town Council hereby authorizes and instructs either of the Mayor or Town Manager or the aforementioned officers' designees to apply for the Grant from the Lee County CDBG-DR Recovery and Resiliency Grant Program and to administer the Grant on behalf of the Town.

Section 3. The Mayor or Town Manager or said officers' designees are each hereby authorized to execute and deliver any documents necessary to apply for, receive and administer the Grant award on behalf of the Town.

Section 4. This Resolution shall take effect immediately upon its adoption by the Town Council of the Town of Fort Myers Beach.

The foregoing Resolution was adopted by the Town Council upon a motion by Vice Mayor Atterholt and seconded by Council Member Woodson, and upon being put to a roll call vote, the result was as follows:
