

RESOLUTION NUMBER 24-136

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA AUTHORIZING THE TOWN MANAGER TO EXECUTE THE 2025 PARTICIPATION REQUEST AND RENEWAL FORM FOR THE FLORIDA RECOVERY OBLIGATION CALCULATION (F-ROC) PROGRAM; AUTHORIZING THE TOWN MANAGER OR THEIR DESIGNEE TO EXECUTE AND SUBMIT RELATED DOCUMENTS NEEDED TO IMPLEMENT AND ADMINISTER THE PROGRAM INCLUDING THE DISASTER READINESS ASSESSMENT AND ABATEMENT ACTIVITIES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

WHEREAS, Article X of the Town Charter of the Town of Fort Myers Beach empowers the Town to adopt, amend, or repeal such ordinances and resolution as may be required for the proper governing of the Town; and

WHEREAS, the Town of Fort Myers Beach, Florida (the “Town”) had the opportunity to participate in the first year of the Florida Division of Emergency Management’s Florida Recovery Obligation Calculation (F-ROC) Program (the “Program”); and

WHEREAS, the Town desires to continue participation in the Program to provide the Town with assistance in identifying risk in our organization and develop a clear action plan that will abate those risks, while standardizing and streamlining the Public Assistance process; and

WHEREAS, as part of participation of the Program, the Town must submit a signed participation and renewal request; and

WHEREAS, the Town Council finds and determines that it is in the best interest of the Town and its citizens to authorize the participation of the Program for the 2025 season and the administration thereof of the Program; and

WHEREAS, the Town desires to authorize the Town Manager or the afore mentioned officer’s designees to submit the 2025 participation documentation and administer Program on behalf of the Town; and

WHEREAS, the Town Council desires to authorize the Town Manager or the aforementioned officer’s designees to execute and deliver all documents necessary to participate in the Program and carry out the administration of same.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE TOWN OF FORT MYERS BEACH AS FOLLOWS:

Section 1. That above recitals are true and correct and are hereby incorporated by reference as though fully set forth herein.

Section 2. That the Town Council hereby authorizes and instructs the Town Manager to participate in the Program for the year 2025 from the Florida Division of Emergency Management and to administer the Program on behalf of the Town.

Section 3. That Town Manager Andrew Hyatt and their designees are each hereby authorized to execute and deliver any documents necessary to opt-in, participate, and administer the Program on behalf of the Town.

Section 4. This Resolution shall take effect immediately upon its adoption by the Town Council of the Town of Fort Myers Beach.

The foregoing Resolution was adopted by the Town Council upon a motion by Council Member Woodson and seconded by Council Member Safford, and upon being put to a roll call vote, the result was as follows:
