AN ORDINANCE OF THE TOWN OF FORT MYERS BEACH, FLORIDA, AMENDING SECTIONS 4.02 "MAYOR," 4.03 "VICE MAYOR," 5.01 "ELECTIONS," AND 5.03 "TERMS OF OFFICE" OF FORT MYERS BEACH TOWN CHARTER, TO UPDATE THE DATE OF TOWN ELECTIONS FROM MARCH TO NOVEMBER AND TO ESTABLISH FOUR (4) YEAR TERMS OF OFFICE FOR TOWN COUNCILMEMBERS, AS APPROVED BY THE VOTERS AT THE MARCH 2020 MUNICIPAL ELECTION; PROVIDING FOR CODIFICATION, SEVERABILITY, SCRIVENER'S ERRORS, CONFLICTS OF LAW, AND AN EFFECTIVE DATE.

Ordinance 24-31 amends the Town Charter, changing the date of the Town election from March to November, and establishing four-year office terms for the members of the Town Council, as approved by the voters during the 2020 municipal election. Both changes were approved by the Town voters, but the changes were never codified or incorporated into the Town Charter. This Ordinance promotes public health, safety, morals, and welfare of the Town's residents by ensuring that the changes approved by the Town's voters are incorporated into and made a part of the Town Charter.
