

ORDINANCE 06-22

AN ORDINANCE AMENDING THE TOWN OF FORT MYERS BEACH ANCHORAGE MANAGEMENT ORDINANCE; PROVIDING AUTHORITY; AMENDMENT TO SECTION 6. COMPOSITION AND APPOINTMENT, SEVERABILITY; EFFECT OF ORDINANCE AND EFFECTIVE DATE.

IT IS HEREBY ORDAINED BY THE TOWN OF FORT MYERS BEACH AS FOLLOWS:

SECTION 1. Authority. This Ordinance is enacted pursuant to the provisions of Chapter 95-494, Laws of Florida, Chapter 166, Florida Statutes, and other applicable provisions of law. Additions to the prior Ordinance(s) are indicated by underlining and deletions to the prior Ordinance(s) are indicated by ~~strike throughs~~.

SECTION 2. The provisions of SECTION 6. Composition and appointment, of the Fort Myers Beach Anchorage Advisory Committee Ordinance 00-14, as amended by Ordinance 04-02, Ordinance 05-12, Ordinance 06-01, and Ordinance 06-11 are further amended to read as follows:

SECTION 6. Composition and appointment. The Anchorage Advisory Committee (AAC) shall consist of a minimum of five (5) members and a maximum of seven (7) members appointed by the Town Council. ~~The Harbormaster shall be a non-voting, ex-officio member.~~

SECTION 3. Severability. If any one of the provisions of this ordinance should be held contrary to any express provision of law or contrary to the policy of express law, although not expressly prohibited, or against public policy, or shall for any reason whatsoever be held invalid, then such provision shall be null and void and shall be deemed separate from the remaining provisions of this ordinance, and in no way affect the validity of all other provisions of this ordinance.

SECTION 4. Effect of Ordinance. The provisions of this Ordinance shall be deemed cumulative and supplemental and shall have no legal effect upon the ordinance establishing the Town Of Fort Myers Beach Anchorage Management Ordinance except as expressly provided.

SECTION 5. Effective Date. This ordinance shall become effective immediately upon its adoption.




